VISA

Nationals of the following countries: Senegal, Republic of Guinea, Gabon and Côte d'Ivoire have not need an entry visa to Morocco. The countries which have an embassy or a Consulate of Morocco on their territory are requested to ask for the visa of entry to Morocco in their countries as soon as possible. ATLAFCO' Secretariat may establish, at the request, a note verbale to the Moroccan authorities for the purposes of facilitating the obtaining of the entry visa..

Similarly, the Secretariat of ATLAFCO will address to the Moroccan authorities to ask them to provide the visas upon arrival to Mohamed V International Airport in Casablanca to all participants from countries where there is no consulate or embassy of Morocco. In this case, the participants concerned will have to provide in advance to the logistic team of the Secretariat of ATLAFCO, a scanned copy of their passport by addressing it to the following addresses (Mkarima241@gmail.com) or (Secretariat.comhafat@gmail.com) the rather possible as soon as possible
